Robert Hutchinson: New Region VIII Co-Chair

Robert Hutchinson is Associate Professor of Music Theory and Composition at the University of Puget Sound in Tacoma, Washington. He received a Ph.D. in Composition from the University of Oregon in 1998, a Master of Music in Composition from Northern Arizona University in 1993, and a Bachelor of Arts in Fine Arts from California State University Bakersfield in 1992.

He hosted the Region VIII Society of Composers' Conference in March 2010. His recent commissions include *Pas de Quatre* for string quartet for the Walla Walla Chamber Music Festival, *The Forest Nocturnal Triptych* for the Peninsula High School Band, *As the Blue Night Descends Upon the World* for the Tacoma Concert Band, *Fantasia on Themes of Mozart* for the Northwest Sinfonietta, *Suite for Wind Quartet* for the Auburn Chamber Winds, *From the Sea to the Stars* for the Tacoma Youth Symphony, and *Liberatio in Morte* for the Oregon Wind Ensemble, Oregon Festival Choirs, and the Oregon Festival of American Music.

Dealing with the Ups and Downs of Being a Composer By Ralph Kendrick

Several weeks ago, I received two rejection letters on the same day for composing opportunities for which I had applied. While rejection is a normal part of any composer's existence, and is normally something I'm able to shrug off, the piling on of bad news in the same day got to me a bit. I began to wonder how other composers dealt with this constant ebb and flow of a little good news and a whole bunch of bad news. An informal survey revealed some interesting results.

Several composers talked about having low expectations when entering contests or performance opportunities. With this approach, they were pleasantly surprised when receiving the news that they had won or had their work selected for a performance. One composer had a heart-wrenching story of being homeless for ten weeks. Given that perspective, he finds having a piece rejected as the least of his worries.

Others discussed the idea of balance in their lives; where being a composer is but one part of their entire existence as a teacher, parent, husband, performer and an active member of their community. The benefits of a balanced approach include multiple sources of good news. Then, the composer just needs to focus on the good news and not the bad. For example, today I was rejected from a competition but so what, I had a great afternoon playing with son.

The successful composer Joan Tower echoes these sentiments when she provides the following advice to young composers. "Don't look to composing to provide the sense of satisfaction in your life. It will always be frustrating. Make sure you have other things in your life which give you satisfaction."

Some fascinating statistics emerged from the survey as well. One composer noted that he wins about one competition a year and submits about one application per week. Another discussed winning two or three competitions out of the 33 he had entered thus far. Though a small sample, these testimonials suggest a paltry success rate of 2–9% for competitions.

Why bother entering then? Several composers highlighted the marketing benefits of entering competitions or submitting to conferences. They felt that getting their name in front of other musicians they did not know provided them with valuable exposure. One composer even said, "I've gotten a variety of performances over the years, from losing competitions."

And it is a bit like the lottery, you can't win if you don't play. Keeping the odds in mind and keeping expectations in check with those odds seems to be a successful approach.

Finally, numerous composers said it was good to remind oneself that we do not compose to win awards; we compose because we have to. We have an innate desire to create, and that process of creating and completing something is satisfying all by itself.



Hutchinson's *Dancing on the Strand* was also presented at the Symposium 29 for New Band Music in Richmond, Virginia, in February 2004 and at the CBDNA Southwestern Division Biennial Convention at Texas Christian University in March 2004. His *Jeux d'Enfants* was selected by the Charles Ives Center for American Music for a June 2002 premiere by the Charleston Symphony Orchestra at the Piccolo Spoleto Festival in Charleston, South Carolina.

Hutchinson is also a jazz bassist and performs professionally in the Seattle-Tacoma area.

On February 26, 2011 Lutenist Dieter Hennings performed with the Eau Claire Chamber Orchestra (ECCO), Ivar Lunde, conductor and music director; the concert, entitled "All American!", featured Mr. Hennings in the world premiere of Steven L. Rosenhaus' Lute Concerto. The concert was held at Grace Lutheran Church in Eau Claire, WI.

Rosenhaus' Lute Concerto is a twomovement work for Baroque lute and a small ensemble consisting of 1 each of flute, oboe, and bassoon, and a small complement of strings. The meditative first movement is contrasted by the lively second movement, which has the sub-title "Sonata Samba"—as in "It's not a samba". The work explores the tonal qualities of the 7-course lute (the instrument has 7 single or pairs of strings) by itself and in juxtaposition with various combinations of the orchestral accompaniment.

Orlando Garcia

The world premiere of Garcia's new work In Memoriam Earle Brown was given by the Miami Symphony Orchestra and conductor Eduardo Marturet on February 12, 2011 at the Wertheim Performing Arts Center Concert Hall and February 13, 2011 at the recently inaugurated New World Center on Miami Beach. The piece was commissioned by the orchestra and its director Eduardo Marturet.

The premiere of Fantasia Concertante (2009) for violin, cello, and orchestra by soloists Duo Parnas (Madalyn and Cicely Parnas) with the Indiana University New Music Ensemble under David Dzubay took place February 5, 2011 at the Jacobs School of Music, Indiana University, Bloomington, IN.

Written for Duo Parnas, Fantasia Concertante is an expansion with orchestra of 'Sigol' for Two, a duo written for them in 2008 and recorded on their Sheffield lab CD "Gare du Nord," a CD chose by Gene Gaudette on his blog as one of the 10 best CDs of 2010.

JOINT MEMBERSHIP (\$75/year): Same benefits as full members
