Remembering Edward Mattila



Composer, Edward Mattila, passed away on March 22, 2013. Mattila studied computer and electronic music at Princeton and Colgate, with degrees from the New England

Conservatory and the University of Minnesota. He was Professor of Music Theory and Composition and Director of the Electronic Music Studio at the University of Kansas. Below is a brief tribute to the life of Edward as remembered by his friends and colleagues.

Ned Mattila (son)

Edward Charles Mattila passed away peacefully on March 22, 2013. He was preceded in death by his loving wife of 53 years, Nancy Norton Mattila. Survivors include a daughter, Amy Fortney of Ft. Collins, Colorado and a son, Edward N. Mattila of Austin, Texas. Edward Mattila was a member of the Kansas University music faculty from 1964 until his retirement in 1998. An active composer of new and electronic music, Mattila directed the KU Electronic Music Studio for many years, and was active in the organization

of SCI (known then as ASUC). I believe he was founding member and served as Co-Chair of Region VI for many years. He was a man of few words but when he spoke it was always to the point and pertinent to the issues. Beneath the calm exterior was a fierce intelligence and a fine compositional voice. He was a pioneer of electronic music and I expect his students at the University of Kansas learned much from him. His music was always powerfully expressive and beautifully constructed. I got to know him best when he and Charles Hoag mounted one of the most memorable SCI National Conferences. John Cage was the keynote speaker for the event, which provided a unique opportunity to interact with one of the seminal figures of the Twentieth Century. I had never been to Lawrence (or anywhere else in Kansas, for that matter) and Ed and his wife were especially hospitable to me. I will miss his gentility, his generosity, and his understated humor.

Gerald Warfield

Ed was a self-effacing guy with great talent. If you met him at a conference he was shy and unassuming, and at the same time very direct. He listened, seldom injected himself into a conversation, yet he had great organizational ability. He mounted a very memorable SCI Region VI conference in 1990. He was conference host at the Department of Music and Dance, University of Kansas-Lawrence which was held in conjunction with the Symposium of Contemporary Music, April 18-21. Ed brought in the British vocal quartet The Electric Phoenix for the occasion as well as Laurie Anderson who appeared on the University New Direction Series. The conference was particularly memorable for Ed bringing in the Lawrence dance department for several of the concerts, both for electronic and acoustic concerts.


Remembering Edwin London

Edwin London, composer, conductor, and Past President of SCI, passed away on January 26, 2013. London was a faculty member at Cleveland State University and the founder of the Cleveland Chamber Symphony. The 2013 National Conference of the Society of Composers, Inc. was dedicated to the memory of London. Below is a brief tribute to the life of Edwin as remembered by his friends and colleagues.

Thomas Wells

Ed was a great American composer whose music speaks in an original voice: bold, eclectic, witty, and always engaging. There were few composers who had Ed's gift for language and text setting. His wit was legendary and you could see a reflection of his wonderfully brilliant mind in the twinkle of his eyes as he would reel off pun after pun, and the richness of his conversation was always dazzling.

On March 17, 2013 at Colonial Heights Presbyterian Church in Portland, Oregon *Jackson Heights*, a one-minute trio for flute, cello and piano, was premiered by Janet Bebb, flute; Christopher Cox, clarinet; and Maria Choban, piano as part of a Cascadia Composers concert.

Arizona Women in Tune premiered Deutsch's commissioned piece *Where Everything is Music* for women's chorus, soprano saxophone (or clarinet), and piano on March 23, 2013 as part of their 20th Anniversary season at Faith Lutheran Church in Phoenix.

Matthew Saunders

On March 27, 2013 the Ohio State University Flute Troupe gave the premiere of Saunders' piece for flute choir, *Nod a Don*. This work was commissioned by Katherine Borst-Jones in honor of Donald E. McGinnis' 95th birthday. Dr. McGinnis was the director of bands at Ohio State from the 40s

through the 70s, and is past president of the American Bandmasters Association

On March 28, 2013 the premiere of *Lady Glides on the Moon* for clarinet and non-pitched percussion was given in Buchanan Hall on the campus of Eastern New Mexico University by Dr. Jennifer Laubenthal, who commissioned the work.

On April 17, 2013 the Florida Gulf Coast University Symphony Orchestra, Dr. David Cole conducting, gave the premiere of Saunders' *Suite for String Orchestra*.

On April 21, 2013 the Lakeland Civic Orchestra, with the composer conducting, gave the premiere of Saunders' film score for Georges Melies 1902 *Le Voyage Dans La Lune* with the film
