SCI 2013 National Conference Review

The Society of Composer's National Conference at The Ohio State University brought back memories, both fond and sad. Tom Wells, SCI President and conference host dedicated the event to the memory of Edwin London who died January 26, 2013 at the age of 84. London, a former president of SCI, was a composer and champion of contemporary music. He taught on the faculties of Smith College, University of Illinois and the Cleveland State University. In his long career he founded the Ineluctable Modality, a choral ensemble specializing in new music and the Cleveland Chamber Symphony. About him, Tom Wells said, "Ed was a great American composer whose music speaks in an original voice: bold, eclectic, witty and always engaging. There were few composers who had Ed's gift for language and text setting. His wit was legendary and you could see a reflection of his wonderfully brilliant mind in the twinkle of his eyes as he would reel off pun after pun, and the richness of his conversation was always dazzling."

Another memory, brought back by our host institution was the SCI conference of 1984. That was the year that Frank Zappa was the keynote speaker. Zappa lived up to his reputation and delivered a provocative speech that has been recalled more frequently than any other keynote speech in the Society's history.

Keynote speaker for the 2013 conference was special guest Joshua Fineberg who has held posts at Peabody, IRCAM, Columbia University, and most recently Boston University where he is the Director of the Center for New Music and the Electronic Music Studio. In his address, entitled *Speaking in Tongues: Creating Meaning with an Unknown Language*, Fineberg spoke both on the involvement of composers in spectral music and on the place of music in the 21st Century. In additional to his compositional and pedagogical activities Fineberg has been a prominent editor and a collaborator with computer scientists and music psychologists and artistic director for numerous recordings.

KH Tan, professor of music at OSU, presented a concert on Thursday of selected pieces from the *KH Tan International Composition Competition for Solo Violin Works*. The focus of this year's competition was "Asian Inspirations," drawing on inspirations from traditional Asian music as well as abstract Eastern philosophies. The grand-prize winner was Chinese composer, Chiayu (www.chiayuhsu.com) with her *Twelve Signs for Solo Violin*.

Of particular note was the performance of commissioned works from the SCI/ASCAP Student Composition Commission competition. The winners presented were Andres Carrizo (his commissioned composition: *Alucinaciones* for saxophone quartet performed by the Anubis Quartet), Elliott Cless (his commissioned composition: *ROT* for saxophone quartet performed by the Black Swamp Saxophone Quartet), and Eric Guinivan (his commissioned composition: *Fractured Light* for wind ensemble performed by the OSU Wind Symphony). Special thanks went to ASCAP and Cia Toscanini, Vice-President for Concert Music for their support of the contest.

The conference extended for three and a half days and

included twelve concerts on which the music of almost one hundred composers were performed. All the resources of The Ohio State University School of Music were marshaled for this event, and the level of performance was consistently high. While all SCI conferences do not have to be of such magnitude, the quality and sheer size of this conference was staggering. Universities, of course, host many conferences, and often these events are showcases for the institution. However, bringing together a hundred composers and playing their pieces is a truly remarkable event. Seldom, on a university campus, is so much done.

Special guest performers included Professor Fali Pavri, pianist, from the Royal Conservatoire in Glasgow; the Anubis Quartet from Chicago; the flute and saxophone duet, the Tower Duo; the Black Swamp Saxophone Quartet; the flute, viola, and harp ensemble, the Cosmos Trio; and the New Music Ensemble from the School of Music at Ohio University.

Members enjoyed four receptions, one each evening of the conference. The gala reception on the last evening was sponsored by ASCAP. Papers were given by Richard Brooks, Kerrith Livengood, Jung Yoon Wie, and Mickie D. Willis.

At the SCI Banquet Saturday evening, a plaque was presented to Richard Brooks for his long association with the Society. The plaque read: "Presented to Richard Brooks in Grateful Appreciation for his many years as Producer of the SCI CD Series,

1991-2009, by the SCI Board of Directors." Also presented at the banquet were two plaques to Tom Wells. One for hosting our conference and one for his years of dedication and service as president of the Society. The plaque read: "Presented to Thomas Wells, President of the Society of Composers, Inc., 2002-2013. In Grateful Appreciation for many years of service to SCI and its members by the SCI Board of Directors." Tom was ably assisted in hosting the conference by Michael Rene Torres, General Manager of the conference. Also by Quinton Jones for coordinating the receptions and Ramsey Sadaka and David Tomasacci who served on the selection committee.

The conference was vast and included more events than any one person could attend. Our host, Tom Wells, in fact, warned conference attendees to choose well what to attend from the program lest they drop from exhaustion. The 2013 conference was an extraordinary event and a fitting tribute to our outgoing president, Thomas Wells.
